- Fixed Income RFP update. Ex. Director reported the due date is May 13, 2022 by 12 noon. The initial screening will most likely take place at the June board meeting.
- There will be two (2) seminar dates for the employees of the Light Plant to be held on June 8th and September 15th. Ex. Director will be making presentations and invited the board members to attend.
- Mass. Retirees Assn. has reported that legislation is moving forward to allow an increase in the cost-of-living adjustment (cola) for FY2023 from 3% up to 5.9% with a local option vote for each individual board. This is being done to assist retirees with keeping up with inflation and the increasing cost of living.

NEW BUSINESS:

Chairman Smith inquired about the retirement expense budget line item that funds the position of Office Clerk. Ex. Director noted that this position remains unfilled after promoting prior office clerk Jessica Gonsalves to Admin. Assistant. Ex. Director explained that there is a need in the office to utilize this position to hire a part-time worker to come in and perform clerical duties - especially the electronic scanning of documents to allow continuation to full conversion of all physical documents into electronic format. This position would also assist with coverage of the office when staff attends Macrs conference and various training seminars etc.
