Investment Performance Q/E 06/30/2018

The Board met with Greg McNeillie of Dahab Associates to review investment performance thru Q/E June 30, 2018. The assets returned +1.7% and was in line with the policy index for the quarter. On a YTD basis, the assets returned +1.5% vs. the policy index of +1.1%. For the quarter, most managers performed within their respective benchmarks except for some slight underperformance from Frontier & Wells Capital (mid-cap equity); Aberdeen & QMA (small-cap equity); Invesco REIT; and Brandywine (global bonds).

Mr. McNeillie reviewed various statistics and the macro economic environment and the Federal Reserve board policies etc. Asset allocation was also reviewed and in line with investment guidelines and targets. The Board placed the report on file and Mr. McNeillie was excused from the meeting.
